RESOLUTION FIXING DATE OF PUBLIC HEARING ON QUESTION OF ANNEXATION PURSUANT TO G.S. 160A-58.2

WHEREAS, a petition requesting annexation of the non-contiguous area described herein has been received; and

WHEREAS, the Town Council has by resolution directed the Town Clerk to investigate the sufficiency of the petition; and

WHEREAS, certification by the Town Clerk as to the sufficiency to the petition has been made;

NOW, THEREFORE, BE IT RESOLVED, by the Town Council of the Town of Boone, North Carolina that:

Section 1. A public hearing on the question of annexation of the non-contiguous area described herein will be held at Council Chambers on Blowing Rock Road at 6:30 p.m. on May 20, 2004.

Section 2. The area proposed for annexation is described as follows:

A 5.226 acre tract, shown as Tract B on the "Recombination Survey" plat

recorded in Plat Book 017 at page 182, located on the south side of old US Hwy 421 approximately 600 feet west of the intersection of said road with new Highway 421 and with the perimeter being surveyed by me, Frank Lee Hayes PLS L-1488, on August 8, 2003 as: BEGINNING on a right-of-way monument in the northern boundary of NC Department of Transportation Project 6.759003T (new Highway US 421), said monument having NCGS NAD '83 coordinates of N=911,088.11 feet and E=1,229,786.31 feet; THENCE from the beginning and with the NC DOT line North 83 degrees 39 minutes 05 seconds West 120.01 feet to a 5/8 inch rebar set, a common corner with Tract A; THENCE with the eastern boundary of said Tract A North 04 degrees 13 minutes 05 seconds East 235.33 feet to a 1/2 inch rebar set; THENCE with the same North 17 degrees 25 minutes 20 seconds East, crossing a 1/2 inch rebar set as reference 435.79 feet, a total distance of 465.02 feet to the center of old US Highway 421; THENCE with the center of said road South 72 degrees 28 minutes 35 seconds East 344.80 feet to the northwest corner of Tract C; Thence leaving the road and with the western boundary of said Tract C South 17 degrees 24 minutes 00 seconds West, crossing a 1/2 inch rebar set as reference at 28.65 feet, a total distance of 114.42 feet to a 1/2 inch rebar set; THENCE with the same South 10 degrees 26 minutes 40 seconds West 181.89 feet to a 1/2 inch rebar set; THENCE with the same South 72 degrees 47 minutes 00 seconds East 19.84 feet to 1/2 inch rebar set; THENCE with the same South 17 degrees 24 minutes 25 seconds West 209.85 feet to a 5/8 inch rebar set in the northern line of the NC DOT property; THENCE with said northern line South 69 degrees 50minute 15 seconds West 271.71 feet to the BEGINNING; being described with bearings and distance relative to the North Carolina Grid System NAD '83 using a combined grid factor of 0.999062.

STATUS ON ARMY CORPS FUNDING

Resource Director Jim Byrne announced that he received verbal communication regarding postponement of all Section 22 funding. Mr. Byrne said this would affect the Phase II project at the Anne Marie/Elizabeth Drive property. He reiterated this was just a postponement of funding and that he should know in October if we will receive funding for FY 2005.

REQUEST PERMISSION TO APPLY FOR GRANT FOR FIRE DEPARTMENT

Fire Chief Reggie Hassler requested permission to apply for a grant from the FEMA fire act. The grant amount is \$78,000 and any match will be included in the Fire Department's budget. Fire Chief Hassler said he has applied for this grant in the past and hopes it will be awarded this time. If awarded the grant funds will purchase specialized equipment used in search and rescue. On a motion by Council member Eggers, seconded by Council member Mason, Council moved to grant permission to the Fire Chief to apply for this grant.

APPOINTMENT OF COMMITTEE FOR PROPERTY LEASE FOR ANNE MARIE/ELIZABETH DRIVE PARK

Mayor Burnley said a committee needs to be appointed to negotiate with the County the property lease for the Anne Marie/Elizabeth Drive park property. Council members Mason and Wilcox volunteered to serve on that committee. On a motion by Council member Eggers, seconded by Council member Clawson, Council moved to appoint Council members Mason and Wilcox, along with the Town Manager, Town Attorney and Resource Director to the committee.

FORMATION OF TASK FORCE FOR NEIGHBORHOOD (SINGLE-FAMILY RESIDENTIAL) OCCUPANCY

Council member Mason said she would like to move forward on forming a task force to discuss the neighborhood (single-family residential) occupancy problems. Ms. Mason said she hoped the task force could look at a rental licensing program. Council members Clawson and Spann volunteered to serve on this task force. Council member Mason said the Task Force should include Development Services Staff, two council members, two members of the Planning Commission and different neighborhood representation. Council member Eggers suggested including property management and ASU Housing office representatives. Council agreed to appoint neighborhood nominees at the May meeting.

DISCUSSION OF PROPOSED SURVEY - CHARTER COMMUNICATIONS CUSTOMER SURVEY

Council member Mason said she was disappointed in Charter's latest customer survey. This survey was required by Council as part of the franchise agreement. Council member Mason said the franchise agreement was adopted last July and Charter is just now completing the survey. Council member Mason also said the survey does not follow the guidelines as specified by the franchise agreement and that Charter has yet to address issues from the 1999 survey. Council member Mason asked that the Cable TV Advisory Committee work with Charter on this survey and that they become more involved to oversee compliance by Charter with the franchise agreement. Council agreed.

DISCUSSION OF REDEVELOPMENT REGULATIONS

Council member Mason asked Council if they want to prepare regulations for redevelopment of properties under 2000 square feet. Council member Mason said new regulations would help small businesses. After little discussion, Council agreed to have the Development Services Department prepare regulations for redevelopment of properties under 2000 square feet.

DISCUSSION OF CONDITIONAL-USE ZONING

Council member Mason asked Council if they want to look at conditional-use district zoning. Council member Mason said, if it is implemented, it will give the Planning Commission more time to do actual planning, since the Board of Adjustment will issue the permits. Ms. Mason said it will streamline the process for both applicants and staff. Council member Wilcox felt that the Town Council, an elected board, should be the final word on any zoning districts. Council member Eggers agreed. Council member Wilcox said since Conditional Use Zoning districts will save time, he felt it important to try to prepare an amendment by the August quarterly public hearing. Council agreed.

DISCUSSION OF NOISE ORDINANCE

Council member Mason said she received a call from a citizen in the community about a noise incident downtown. Ms. Mason indicated that the Town Attorney felt that some of the language in the Noise Ordinance is vague. Council member Mason suggested the Town Attorney review the Noise Ordinance and make recommendations on suggested changes. Town Manager Greg Young pointed out that the downtown situation exists because of the mixed uses, i.e. apartments and late night businesses. Council agreed to have the Town Attorney review the Noise Ordinance and prepare any amendments needed.

DISCUSSION OF LEASH LAW

Council member Eggers said he is constantly receiving complaints about dogs causing property damage, personal injury, noise and just being a nuisance and agreed it is a touchy issue since most dogs are beloved pets. Council member Eggers suggested having the Town Attorney review different options regarding a leash law. He said there would be some expense to the Town and it would require cooperation with the County Animal Control. Council members Clawson and Mason agreed it would be good to look at different options. Council member Wilcox pointed out that this matter has been discussed by Council in the past and that it will be a

very expensive prospect. Council member Eggers agreed but felt the Town Attorney could explore different options and that sometimes just the existence of a law on the books is a deterrent. Council agreed to have the Town Attorney research a leash law and report back to Council.

ABC BOARD APPOINTMENT

Council accepted the nominations of Bob McConnell and Candy Winebarger at the last meeting. The following votes were cast:

REQUESTED APPEARANCE - BLUE MURROW

Ms. Murrow did not appear before Council.

REQUESTED APPEARANCE - CEYLON BARCLAY

Mr. Ceylon Barclay, General Manager of the Horn-In-The-West, appeared before Council to request the Town's assistance. Mr. Barclay said the Horn is 53 years old and revealing its age. Mr. Barclay said he has \$225,000 out in grant applications and that the Southern Appalachian Historical Association (SAHA) has \$270,000 in assets, but only \$10,000 in the bank. Mr. Barclay pointed out that there are 23 buildings on the Town's property, but no property insurance on those buildings. Mr. Barclay said the SAHA by-laws have not been revised since 1970, and, at present, there are only a few board members remaining. Mr. Barclay requested that the Town assist the Horn financially or with contract labor to renovate the existing facility. Mr. Dan Cook, SAHA Board Member, said he would personally contact the SAHA membership to convene and appoint a new board of directors next week. Mr. Michael Scialabba, Artistic Director, said, unless repairs are made to the facility, there may not be a show this year. Mr. Scialabba asked the Town for any resources that can be provided to make this a safe season. Mr. Scialabba said last year the Horn had its worst season, but mostly because of the weather. He indicated that there is a short amount of time to complete the work before the June opening, but that there is a very large community of people that want to help and see this show succeed. Mayor Burnley said she appreciated their remarks and felt that the Horn is a great cultural and economic benefit to the County. Town Manager Greg Young recommended that the Town remain supportive of SAHA and Horn-in-the-West and appropriate up to \$25,000 for immediate repairs to correct safety issues on the Town's property. Mr. Young also recommended that the Town Council address other facility improvements to the Town's property during regular budget deliberations, and in light of the legal questions and issues surrounding SAHA board and management he recommended that all actions regarding SAHA and Horn-in-the-West be deferred until the Town Attorney has the opportunity to provide Town Council with advice on these matters. On a motion by Council member Clawson, seconded by Council member Wilcox, Council moved to accept the Town Manager's recommendations. Before voting, Council member Mason suggested revising the lease since it is ambiguous and said the Town probably would not be dealing with this situation if the lease were more clear.

REQUESTED APPEARANCE - BOSTIC DEVELOPMENT

Mr. Joe Baggett of Four Season Management appeared before Council to request water and sewer service to property located off Highway 421. Mr. Baggett said a portion of the property is located in the Town limits, but a larger portion is located in the ETJ and an even smaller portion is located outside Town zoning limits. Council member Mason said this property should be closely considered since it is in three different zoning districts and may be subject to the Ridge Law. Council member Clawson suggested tabling a decision on this matter until after the Town receives the water study. Council member Eggers asked if there is a development plan in place. Mr. Steve Johnson of Bostic Development said no, that they have only now begun site planning. Council member Mason asked how much of the property is located in the primary growth area. Planner Jane Shook responded that half the property is considered a primary growth area. Mayor

Burnley asked when the water study would be complete, explaining that the Town has been asked to interconnect water systems with the Town of Blowing Rock and ASU. Public Utilities Director Rick Miller said the preliminary report should be ready in June with the final study complete by August. Council agreed to wait on the water study before making a decision on this request.

REQUESTED APPEARANCE - DONALD MORRISON

Mr. Donald Morrison appeared before Council to request water and sewer hook-up to property located off Highway 105 Bypass. Mr. Morrison explained that this property is part of a subdivision and is located outside the Town's ETJ. Previous requests in the subdivision have been approved without annexation, double rates. Council member Mason said she was concerned about our continuing to get these individual requests, citing that it is not good planning. Town Manager Greg Young agreed and said if the Town were to annex the entire subdivision all water lines would have to be replaced to meet fire flows. Again, Council agreed to wait until completion of the water study before making a decision on this request.

REQUESTED APPEARANCE - NC FOREST SERVICE

Mr. Rudy Johnson, Watauga County Forest Ranger, appeared before Council to request a water and sewer tap for a new office off the Landfill Road. Mr. Johnson said this trailer will be located adjacent to the County Animal Control office. Council member Wilcox felt the request should be approved because of the contamination hardship in the area. Council member Mason agreed that our policy allows for cooperation between local governments. Council member Clawson suggested adding a condition that this line will be used only for a governmental office. Town Manager Greg Young said that stipulation, "for governmental purpose, because of groundwater contamination" could be included. Town Manager Young said another condition should be that their sewer connection should comply with the Building and Water and Sewer Code. On a motion by Council member Eggers, seconded by Council member Wilcox, Council moved to grant the water and sewer request, because of groundwater contamination in the area, contingent upon the service remaining as a governmental purpose and that the connections comply with the Building and Water and Sewer Codes.

Dr. Matt Robinson, Associate Professor of Criminal Justice at ASU, appeared before Council to present a resolution denouncing the US Patriot Act. Dr. Robinson requested that the resolution be adopted at the May meeting and announced that by adopting this resolution the Town will be joining New York City and Washington, DC, along with hundreds of other municipalities, in denouncing the Patriot Act.
